- All Judges, instructors/coaches, team leaders, officials and archers are invited to attend.
- <u>USAA Candidate</u>, <u>Regional and National judges</u> are welcome and recommended for all USAA judges to officiate nationally. USA Archery Regional and National Judge certification testing is offered to eligible USAA judges.
- <u>Continental Judges certification applicants.</u> Continental Judge certification testing is available to eligible national judges.
- <u>International Judge Candidate certification applicants.</u> International Judge Candidate certification testing is available to eligible Continental judges.
- Seminar participants are welcome to tour and observe 2014 Arizona Cup field set up and operations.

Seminar Registration:

- Seminar fee: \$150 USD includes classroom seminar facility, presentations, breakfasts, lunch and light refreshments on April 1 and 2.
